The Ring of Fire Secretariat, a Crown agency left over from the previous Wynne government, remains in place, but it's unclear whether the negotiating format to consult with area First Nations close to the mineral deposits – known as Regional Framework Agreement process – will be restarted. "The Ring of Fire is a top priority for our government. Solomon added "A few years ago we established a Treaty Relationship Discussion Table with Ontario to discuss issues such as resource development, environmental protection and supporting our children. "Since the Ford government came to power, there has been no indication by this Government on the future of the Treaty Table. "Now they have delivered basically a slap in the face by eliminating these independent bodies which are keys to helping our First Nations – and also declaring that they will be plowing ahead with the Ring of Fire development. "This is a mining development about which the Ontario government has had no consultation with our First Nation, contrary to every recent Supreme Court decision." The Grand Chief finished with this warning, "Things have changed. I can assure Premier Doug Ford and his government that if he continues in this direction, the Mushkegowuk First Nations will resist his efforts and stand up for what is right."

ONTARIO SUPPORTING FAR NORTH WINTER ROADS NETWORK

MARTEN FALLS FIRST NATION SELECTS AECOM TO CONDUCT ROAD STUDY AND ENVIRONMENTAL ASSESSMENT FOR NEW ALL-SEASON ROAD

Marten Falls First Nation and Ontario announced the agreement to study a long-awaited community access road on August 21, 2017. Since then, Marten Falls has entered into a voluntary agreement with the Ministry of Environment and Climate Change (MOECC) to conduct an Individual Environmental Assessment (EA) and Preliminary Design (PD) for the proposed community access road from Marten Falls First Nation going south to existing provincial highways. The First Nation has established a project team and conducted one field season of baseline surveys; but to carry out the full suite of technical services and studies, and other steps within the EA process, Marten Falls has brought on AECOM. https://bit.ly/2DViyxG
