KIRKLAND LAKE COUNCIL REMINDS PROVINCE OF ITS CAMPAIGN PLEDGE TO SHARE RESOURCE REVENUE

Resource revenue sharing was a hot topic for provincial leaders swinging through the north during the Ontario election last spring. The NDP pledged to give all \$41 million in annual provincial mining tax revenue to First Nations. The Progressive Conservatives promised to give First Nations, cities and towns in the north a cut of the provincial revenue from all resource industries, worth between \$20 and \$30 million every year. "They're going to get a fair percentage of the revenues and we're going to look out for the people of the north," now Premier Doug Ford said in an interview with CBC during the 2018 election campaign. But little has been said since the Conservatives formed the government six months ago.

OPINION: EXCLUDING HUMAN RIGHTS FROM PROJECT ASSESSMENT AND APPROVAL IS AN UNWORKABLE PROPOSITION

The current federal system for review and regulation of resource development proposals is broken. Not because, as some critics claim, the process is too slow and cumbersome, but because in a democratic society, governments simply cannot ignore the human rights implications of their decisions, especially in the era of the United Nations Declaration on the Rights of Indigenous Peoples. Although the protection of human rights is an explicit constitutional imperative, current federal impact assessment legislation does not include any direct or explicit reference to rights protections. This is despite the fact that large-scale resource development projects will have profound impacts on the Indigenous nations whose lands and jurisdictions are inevitably implicated, as well as for the Indigenous and non-Indigenous communities that host the workforces which build and maintain such projects. And, it is all too clear in the discussions with Indigenous leadership, that Canada's governments and proponents must plan the process at an early stage with Indigenous nations to meet an expectation of co-decision-making procedures.
