#### MAKING INROADS ON THE RING OF FIRE?

Depending on who you talk to, Noront Resources has either taken a key step forward to meeting its production targets at its Eagle's Nest nickel-copper-platinum-palladium development in the Ring of Fire (ROF) or a giant step backwards. To date, the Toronto base metals company has handed off environmental assessment (EA) permitting for the contentious all-weather community access road into the site to local First Nations – while delaying by another year its production timeline to 2023. "Our production depends entirely on the timing of the road construction and they still have to finish the EA and physical construction of the road," says Noront CEO Alan Coutts. "You can't rush these assessments; they have to be done properly, or they will end up in the courts."

#### NEW COALITION SAYS EAST-WEST ROUTE TO RING OF FIRE NEEDED NOW

The East-West Ring of Fire Road Coalition (EWRFC) is a new organization at the world's largest mining conference, the Prospectors and Developers Association of Canada conference (#PDAC2019) advocating for an "East - West road" to access the Ring of Fire. The EWRFC contends this route will benefit the greatest number of Ontario communities, providing all-season road access, increasing the range of economic opportunities associated with the Ring of Fire - a massive deposit of the mineral chromite, with an estimate value of \$60 billion. The EWRFC was conceived to represent municipalities, First Nation communities and businesses in Northwestern Ontario supporting the construction of a four-season access road into the Far North. Which will build on the current success of First Nation businesses in Sioux Lookout.

Lawrance said one of the benefits of the route is that its construction would align well with construction of the Wataynikaneyap Power line in the region. "They will need roads to develop this power line, and having an all-weather road will make this a lot easier," he said. Lawrance said he was joined by representatives of Cat Lake and Kitchenuhmaykoosib Inninuwug First Nations at Tuesday's event, and added that some other communities including Red Lake and Pickle Lake are supportive of the coalition. He said they plan to reach out to others as well. While the eastwest route was first proposed by the mining company Noront, Lawrance said the Ring of Fire deposit isn't the only reason to build year-round roads in the north.
