BIG CHANGES TO ONTARIO CROWN LIABILITY

The proposed Crown Liability and Proceedings Act proposes to do the following, among other things: • Extinguish any cause of action for any acts of a legislative nature • Extinguish any cause of action for decisions of a regulatory nature (even if they are made negligently) • Extinguish any cause of action for policy decisions, including program funding and termination, and the supervision, oversight and control of programs • Expand the immunity of the Crown for actions in tort; and, • Require plaintiffs to seek leave of the Court when alleging bad faith or misfeasance.

The proposal is very new and OKT has not yet conducted a full analysis of the effects that this might have on section 35 rights and other rights and interests of First Nations. However, we expect that it could have sweeping effects on Crown liability for institutional and regulatory failures with respect to First Nations, including in child protection and environmental regulation. NORONT EXPLORATION UPDATE FOR MCFALDS NO. 8 VMS DISCOVERY

Noront Resources Ltd. is pleased to provide an update on the 2019 Phase-1 exploration program at the company's 85% owned McFaulds volcanogenic massive sulphide (VMS) property in the Ring of Fire. The 2,059-metre copper-zinc focused program was completed in March. It was designed to test the down-dip continuity of the McFaulds No. 8 VMS deposit, which previously returned 26.4 metres of massive sulfide in hole MCF-18-98 grading 2.1% copper, 3.4% zinc, 5.5 grams per tonne silver and 0.5 grams per tonne gold.

NEARLY 400 FOOTBALL FIELDS WORTH OF LAND RECLAIMED BY THE END OF 2019 AT VICTOR MINE

The \$15.4 million reclamation program begins with earthworks where the team will re-shape the mine rock stockpiles to smooth them and bring back the land's natural contouring, and cap the surface with overburden and muskeg in areas to be planted. The overburden contains the mineral soil and the muskeg provides organic matter and improves soil structure that the plants will need. During the spring and fall, 668,000 live stems, shrubs and plant plugs will be planted, many of which were grown on-site. In order to stabilize the soil while the shrubs and trees grow and spread, 177 kg of locally harvested seeds collected last year will be tilled in for native grass cover mimicking early ecosystem succession.

More than 210,000 plants will be propagated on site in the mine's specialized crop box - a modular vertical greenhouse facility inside a sea can – which was brought to site in 2016.

Coutts said Noront is also funding area First Nations to lead the environmental assessment process. Noront will provide the capital and technical support, but the First Nations will be responsible for hiring the engineering and environmental firms to do the work, incorporating their traditional knowledge into the permitting process. And Marten Falls First Nation, which, along with Webequie First Nation, are traditional users of the land there, has signed on to become a shareholder of Noront. Coutts said this type of active engagement should, and likely will, become the norm for any mine development from now on.
