Fort William First Nation and the City of Thunder Bay have reached common ground on a sizeable spread of largely vacant industrial land. For the past three years, the neighbouring communities have been huddling on a monthly basis to strategize how to make 1,100 acres of brownfield property on the reserve development-ready for tenants. The group recently announced the Fort William First Nation Industrial Lands are ripe for businesses engaged in the mining, forestry, transportation, energy, manufacturing, and service and supply sectors. "We're open to many ideas really," said Pelletier. "We've been pursuing a number of them, but getting the lands better organized would be conducive toward attracting more tenants."

# WHY B.C.'S INDIGENOUS RIGHTS BILL IS 'IMPRACTICALLY BROAD' AND INCONSISTENT WITH CANADIAN LAW Financial Post – Nov 29

Thomas Isaac, a partner in Cassels Brock & Blackwell LLP's Vancouver office, believes that's virtually impossible because UNDRIP requires governments to obtain "free, prior and informed consent" (FPIC) before developing any project affecting the lands and territories of Indigenous peoples. "FPIC can be interpreted to imply that governments cannot act without the consent of Indigenous peoples even when such actions are matters of general policy for the good of society, and otherwise justifiable under Canadian law," he said. But, he maintains, that's inconsistent with Canadian law, which requires a standard of "meaningful consultation" with Indigenous groups with regard to projects affecting their land. Our Indigenous rights regime, as articulated by the Supreme Court of Canada (SCC), mandates a consideration of both the Indigenous perspective and the broader, societal perspective," Issac said. "It recognizes that, at times, broader, societal interests justify potential incursions on Indigenous rights." By failing to account for this "fundamental incompatibility," Isaac concludes, Bill 41 cannot advance the very objective of furthering the reconciliation it sets out to achieve.
