FORTESCUE AWARDS \$165M CONTRACT TO SODEXO JV

Sodexo, together with Native Title businesses in the Pilbara, has won a contract to provide village services for Fortescue Metals Group in Western Australia. The contracts involve three individual joint ventures agreements with Sodexo and Aboriginal-owned businesses Palyku Enterprises, Karlka Faacilities Management and Kariyarra Hospitality Services. The contracts, collectively worth \$165 million over three years, include catering, accommodation management and lifestyle and recreation services. Sodexo will work in a JV with Native Title groups to ensure positive community engagement and quality of service at the Hamilton, Cloudbreak and Christmas Creek camps.

Noront Resources Ltd. has extended the terms of its current debt facilities with Franco-Nevada Corporation and Resource Capital Fund V L.P. The Company's loan with Franco-Nevada has been extended to September 30, 2022, and the maturity of its convertible debenture with RCF V has been extended to September 30, 2021. PARTNERS IN GERALDTON-AREA GOLD PROJECT HEADED TO COURT

A dispute has developed between two partners looking to develop a gold mine near Geraldton. A Centerra Gold Inc. subsidiary has filed a statement of claim in Superior Court against Thunder Bay-based Premier Gold Mines. The pair are 50/50 partners in Greenstone Gold Mines, a company they established to develop the Hardrock project a few kilometres south of Geraldton. On Friday, Premier announced that Toronto-based Centerra filed a claim this month seeking a declaration that the 2019 Hardrock Project update submitted by Greenstone Gold should not be considered a "feasibility study" as defined in their partnership agreement.

NORONT RESOURCES PRESIDENT AND CEO RESPONDS TO OPPOSITION TO FERROCHROME SMELTER IN SSM

"...I haven't had a chance to talk to them (Batchewana First Nations) at this point as it was just before Christmas (when they made their announcement); I think it's fair though, as we would be reluctant to approve the project at this stage to. It's very very premature, there's no information out there. At this stage, we are just completing economic assessments, and we haven't even advanced the design work to a point where we can perform test work; so it's really premature to make an evaluation, so it's hard to say the project is endorseable until a lot of that work gets done. That work will get done in the next two to three years." Mr Coutts was not surprised and expected that there would be opposition at this stage whether is was in SSM, Sudbury, Timmins, or Thunder Bay.

RISE IN ROBOTS IN NORTHERN ONTARIO? NOT SO MUCH, STUDY SAYS

Moazzami says many tradespeople in Northern Ontario are reaching the age of retirement which means workers at the Ring of Fire will need to be imported from elsewhere. While Indigenous communities are poised to benefit, Moazzami says without more education, they will not reap the benefits for long.

"The Ring of Fire will increase demand for skills well above the regional supply as most tradespeople are close to retirement in northern regions. Thus, many migrant workers will be employed at the site," he says. "The northern Indigenous population will be the primary beneficiary of jobs in the initial stages of development. However, given the relatively low levels of educational achievement among the northern Indigenous workforce, the prospect of benefiting from later stages of development is slim."

ENVIRONMENTAL CHARGES AGAINST DEBEERS MINE NEAR ATTAWAPISKAT GO TO TRIAL, FOLLOWING APPEAL

The battle over mercury testing at the DeBeers diamond mine near Attawapiskat will continue to be fought in the courts, beginning Thursday in Timmins. Environmental group Ecojustice, representing the Wildlands League, first alleged the mining company broke the law by not properly reporting test results back in 2016. But when it took more than 18 months to get the case to trial, as required by the Jordan principle set by the Supreme Court, the charges were tossed out by a court in 2018. Ecojustice appealed that ruling in June 2019, and last month, Justice D.A. Thomas said the case should continue.

MPP COUTEAU UNVEILS NORTHERN ONTARIO POLICY PAPER

In the latest in a series of detailed policy papers, MPP and Ontario Liberal leadership candidate Michael Coteau unveiled a thorough plan to focus on Northern Ontario's representation at Queen's Park in order to better address goals around environmental protection, job creation and improving public services.

Coteau's commitments to Northern Ontario fall into four broad goals: 1. Put in place a new approach for Queen's Park to work in collaboration with Northern Ontario and Indigenous communities. Establish an annual cabinet meeting in Northern Ontario Re-establish a stand-alone Minister for Indigenous Reconciliation Create a Premier's Northern Advisory Council.
