### NORTHERN PROSPECTORS LOOK TO BOOK THEIR VISIBIILITY

Garry Clark, executive director of the Ontario Prospectors Association (OPA), said the mining sequence of discovery and development is faltering right now. Since the economic crash of 2008, investor interest in early-stage exploration has largely been in the dumper, despite the uptick in value of various mineral commodities. "Grassroots exploration isn't happening as much as it should," said Clark. The OPA is also waging a campaign to convince the Ford government to increase the provincial flow-through share tax credit to help fuel exploration. Flow-through shares have historically been the exploration industry's lifeline during commodity downcycles. The exploration community is circulating an online petition to boost the credit from 5 per cent to 25 per cent to put Ontario on a competitive plain with other provinces like Québec (38.75 per cent) and British Columbia (30 per cent). Ottawa provides a complementary federal tax credit of 15 per cent.

#### CORPORATIONS DON'T SEEM TO UNDERSTAND INDIGENOUS JURISDICTION

The differences between band leadership and traditional leadership have jurisdictional consequences. The authority of the bands comes from Canada's Indian Act, which many Indigenous people reject. Conversely, the authority of the Wet'suwet'en hereditary leadership predates European contact. Band leadership has authority over reserve lands. Conversely, traditional leadership has authority over a nation's traditional territory, which subsumes and exceeds reserve lands. That authority has been acknowledged and upheld by the Supreme Court of Canada. Indigenous people will continue to use diverse means to assert and defend their jurisdiction. Corporations seeking to operate on Indigenous territory must prove they understand the meaning of Indigenous jurisdiction. Until they do, investors should seek their returns elsewhere.

#### IMPACT ASSESSMENT AGENCY OF CANADA INITIATE REGIONAL ASSESSMENT ON RING OF FIRE
