#### THUNDER BAY COULD BE THE SITE FOR A NORTHWESTERN ONTARIO LITHIUM MINERAL PROCESSING HUB

Two northwestern Ontario exploration and mine development companies are eyeing Thunder Bay as a potential site for a lithium processing plant. Toronto's Avalon Advanced Materials and Rock Tech Lithium of Vancouver signed a letter of intent to team up on establishing a facility that makes lithium sulphate, a chemical used in making lithium-ion batteries. It would the first facility of its type in North America, said Avalon president-CEO Don Bubar in an interview with Northern Ontario Business. The facility would accept lithium mineral concentrates from Avalon's Separation Rapids deposit, 70 kilometres north of Kenora, and Rock Tech's Georgia Lake deposit, located 17 kilometres south of the town of Beardmore, just off Highway 11

#### PRIVATE MEMBER'S BILL SEEKS AFFORDABLE HIGH-SPEED INTERNET PROVINCEWIDE BY 2030

Ontario is one step closer to bringing affordable high-speed internet to all families in the province, after a private member's bill from NDP Deputy Leader and Timiskaming-Cochrane MPP John Vanthof passed its second reading on Nov. 26. It still faces major hurdles, however, as private members' bills rarely succeed in majority governments. If passed into law, Bill 226, Broadband is an Essential Service Act, would set a 2030 deadline for making affordable high-speed internet available provincewide.

Pikangikum First Nation will be the first community in Canada to be connected to Starlink's satellite internet network. Kenora-based IT company FSET collaborated with SpaceX about the remote community's desperate need for internet to help secure the project. On November 26th, FSET's work to launch the project and begin connecting the community gets underway. "Access to fast, reliable, and even the most basic internet services enjoyed by most Canadians is long overdue for Pikangikum First Nation; especially for its children, youth, and young adults who make up 75% of the

population," FSET founders Nicole and David Brown said in a statement. "We are thrilled with to work with SpaceX and the delivery of Starlink for Pikangikum – recognizing the community's unique needs and the opportunities that connectivity will create to enhance community outcomes. With all regulatory approvals now in place, this important step towards equality of opportunity begins today."

# FIRST NATIONS BILL 197 LAWSUIT ADVANCES AS ONTARIO MAKES EMPTY OFFERS TO CONSULT, LAWYER SAYS CBC – Nov 27

Changes to the Environmental Assessment Act (EAA) brought about by the passage of Bill 197 in July eliminated the need for environmental assessments for any public projects unless specifically called for by regulations; previously, the EAA mandated environmental assessments for all public projects unless specifically excluded by regulations. The minister of environment, conservation and parks has reached out to individual First Nations offering to consult with them about the creation of the new regulations, which will spell out which projects qualify for assessment, said Kate Kempton, the lead counsel on the case and a partner with Olthuis Kleer Townshend LLP.
